New Rule Changes for Family Day Care and Large Family Child Care Homes FAQ

5 Staff Training

Can the Fire Extinguisher Training count for annual in-service hours?	Yes, Fire Extinguisher Training may be used towards the annual in-service requirement for the licensure year it was completed. Please ensure to log the training on the In-service Training Record CF-FSP 5268A and attach supporting documents.
Is there an expiration date for the Fire Extinguisher Training?	There is no expiration date for this training. This is a onetime training requirement.
Can the Fire Extinguisher Training be taken online?	Yes, online training is acceptable.
How long do new employees have to complete the Fire Extinguisher Training?	Employees of a Large Family Child Care Home must complete Fire Extinguisher Training within 30 days of employment.
If a provider has already completed the Family Child Care Home 30 HR training, are they still required to take the Safe Sleep Training?	No, the Family Child Care Home 30 HR training will be accepted towards meeting the Safe Sleep Training requirement. However, providers are encouraged to complete a Safe Sleep Training course as a refresher course. The additional training course can be used towards in-service.
Does School Readiness require substitutes in FDCH/LFCCH to have the Pre-Service Training?	School Readiness Program Health and Safety Standards Handbook for homes, dated February 2017, page 31, paragraph 17.1, states, "All pre-service training requirements listed below must be completed by the school readiness program operator, employee(s), volunteers and substitutes, each as defined in this handbook, within 90 days of initial employment with any provider participating in the school readiness program." Please be advised that in addition to meeting the School Readiness pre-service
	requirement child care personnel in a family day care home/large family child care home must meet licensing requirements for training within the allotted time frames listed in the handbook.

Are water tables okay to use?	Water tables can be used for water play. However, the children's bodies and bottoms

Does the documentation for alternate sleep position need to be from the parent, physician or both?	The documentation for alternate sleep position must be from the child's physician.
Can crib mobiles be used for infants who cannot roll over or sit up in cribs?	Hanging mobiles are prohibited for all infant cribs regardless of the infant age and/or development.
Can a light blanket be used for infants when sleeping?	Upon further review, it has been determined that a light receiving blanket would not be acceptable in accordance with safe sleep practices. Providers are encouraged to work with parents in providing comfortable clothing for napping/sleeping. Additionally the provider must maintain a comfortable temperature in the room.
Is a written sleep plan required for each child or just the children with special needs?	A safe sleep plan must be written to include general sleeping practices and arrangements for all of the children in care. If the provider cares for infants the plan must also include safe crib sleeping practices.
Are candles prohibited?	Yes, Candles are considered a hazard and must not be used while children are in care.
What type of training is acceptable to meet the medical training requirement for large family child care employees?	Training provided by the health department, the child's physician/nurse, or the parent who has been trained by a physician are all acceptable options for meeting this requirement.

8 Children's Records

Is an additional attendance sheet required if the provider already has a parent sign in and out sheet?	If the parent sign in and out sheet includes all of the required elements for the daily attendance record (date, child's name, arrival time, departure time, notes regarding any absences, etc) then one document will suffice. However if the sign in and out sheet does not include all required elements a separate log would have to be maintained.
As it relates to the new requirement to call parents when the child is not present at the program an hour after the child's normal arrival time; what approach can providers use if a child arrives at various times on a regular basis?	The Department recommends establishing a policy requiring the parent to notify the home provider by a certain time if the child will be absent for that day. Setting a cutoff time that parent's must adhere to will cover children with various arrival times. For example if the cutoff time to call is set for 9AM and by 10AM a child is not there and the parent hasn't called; then at that point the provider would be required to call the parent.
Can providers use text messages to the parent to meet the new 1hour contact requirement?	Yes. Providers can use a variety of different methods to contact the parent/emergency contacts; such as by phone call, text message, email, mobile communication app, etc. All attempts must be documented.
